A message from the Secretary-General



In 2024 the global democratic decline continued. Long-standing challenges to democracy and democratic institutions persisted in all parts of the world and at every level of democratic performance. Many countries that were already struggling saw further deterioration, while some of the world's most robust democracies faced mounting threats.

Despite these ongoing challenges, 2024 also saw significant changes. It was the greatest year of elections in history, with over 70 countries heading to the polls. In many of these electoral contests from Botswana and Senegal to the United Kingdom and the United States—power changed hands through the ballot box. Globally, these elections took place in a context of growing uncertainty. Rapid technological change raised questions about how democratic institutions can use artificial intelligence to improve their work—and how to prevent those same technologies from undermining democracy. At the same time, another force was also reshaping the democratic landscape—climate change. No longer just a long-term risk for democracies, it is a threat to fair elections here and now.

Across this landscape of continuity and change, the International Institute for Democracy and Electoral Assistance (International IDEA) helped its Member States and partners both to understand these complex challenges and to address them. Working on the front lines of democracy, our experts in election management, constitutional design, and political participation and representation supported national authorities and grassroots activists alike.

This report provides a series of snapshots of how this work made a difference last year, across domains of policy research, capacity building, convening and advocacy. In 2024 we concentrated our attention on the urgent need to protect elections—by producing knowledge on trends in participation and representation, by enhancing interagency coordination to address disinformation and other threats, by gathering our Member States for candid exchanges about electoral integrity and by focusing our first global institutional advocacy campaign on this topic.

Meanwhile, our innovative programmes also reinforced democratic resilience in the face of digitalization and climate change; helped raise ethical standards in the European Parliament elections and in the Gambian Parliament; and mediated dialogues between governments, political parties, civil society and citizens, from Bhutan to Peru, and through our coordination of the Global Democracy Coalition.

With a quarter of humanity included in our intergovernmental membership and operational activities around the globe, we have a strong claim to being the most representative voice, forum and actor for democracy in the world. As democracy comes under growing pressure—and becomes ever more needed—this report showcases how our work remains so effective and so vital.





In 2024 International IDEA launched a programme of thematic dialogues with and among Member States. The dialogues, which enabled participants to learn from one another about key issues related to democracy, took place in two successful and engaging series.

First, the Australian Electoral Commission, in partnership with International IDEA, initiated a series of virtual seminars for electoral practitioners called the Canberra Series on Electoral Integrity. The strong reception of and high level of participation in these seminars led the Swedish Election Authority and the Swedish Ministry for Foreign Affairs to join the partnership and convene a second series of seminars. The aim of the seminars is to forge sustainable connections between technical and political issues and communities and between the national and the global levels.

Second, International IDEA partnered with Luxembourg, the 2024 Chair of the Institute's Council of Member States, to develop a series called 'Democracy Exchanges on Gender'. These meetings were dedicated to Sustainable Development Goal 5.5, on women's political participation, and to gender-related aspects of policy debates on digitalization and climate change. The series highlighted good practices, identified critical drivers of effective policies, proposed areas for collective action and supported Luxembourg's leadership efforts as the Chair to highlight the intersection of gender and democracy.

#ProtectElections: A global advocacy campaign

In 2024 International IDEA designed and executed its first global annual advocacy campaign, focused on electoral integrity. At the start of the year, as countries that together account for half the world's population prepared to go to the polls, the Institute resolved to redouble its focus on protecting democratic elections.

International IDEA delivered on this commitment by developing the capacity of electoral authorities to manage risk, by convening dialogues to exchange good electoral practices among the electoral management bodies and foreign ministries in the Institute's Member States, and by generating and disseminating knowledge about trends through the 2024 Global State of Democracy report and other publications. The campaign reinforced the Institute's voice as a champion of free and fair elections, while strengthening synergies across teams and regions. One hallmark of the campaign was a new website landing page highlighting developments in elections worldwide.

Updated regularly, this page quickly became a reference tool for governments, media and researchers globally. The campaign's frequent media advisories generated some 6,000 mentions of International IDEA related to elections, including in *The New York Times, The Economist* and other leading publications.

Protecting Elections: The power of interagency cooperation

Funding:

Electoral integrity is under increasing pressure in both transitional and well-established democracies. The 2024 super-cycle election year highlighted the complexities involved in safeguarding electoral processes amid challenges such as democratic backsliding, natural and human-made disasters, cybersecurity threats, and the spread of mis- and disinformation.

As a global convener, International IDEA has a long history of promoting interagency cooperation to strengthen democracy and electoral integrity. Through Protecting Electoral Processes in the Information Environment project—the Institute has supported partners in Fiji, Finland, Libya, Mauritius and Paraguay in strengthening their collaboration with stakeholders.

By bringing together diverse actors through workshop and training events to identify and map risks, refine


response frameworks, develop road maps for strategy implementation and assess joint information needs, International IDEA has fostered stronger relationships, built shared capacity, and enhanced interagency coordination and preparedness among electoral stakeholders. This approach continues to drive innovations in how elections are managed and safeguarded worldwide.

Fifteen countries experienced extreme weather events during election periods in 2024. International IDEA is raising awareness of the increasing threats that natural hazards—particularly climate-related events such as floods, heat waves, tropical storms and wildfires—pose to electoral processes. The growing evidence of their impact on electoral processes can be seen on the webpage Impact of Natural Hazards and Elections, which International IDEA initiated in 2022 and updates frequently. The page includes a global analysis, an interactive dashboard with illustrative briefs, case studies and podcasts on the topic.

A key priority has been to engage with communities focused on climate change and disaster risk reduction—for example, by strengthening collaboration with the UN Office for Disaster Risk Reduction (UNDRR). International IDEA's Electoral Processes team now regularly publishes knowledge resources on UNDRR's news portal, PreventionWeb, which attracts 210,000 monthly visitors and has provided expertise and feedback on publications released by the Council on Foreign Relations and Climate Central.

Global State of Democracy wins worldwide media attention, while Ghanaian Parliament references report

As in previous years, International IDEA's <u>Global State of Democracy (GSoD) report</u> was an important source of data and analysis for public officials throughout 2024. More than 350 media outlets from around the world, including ABC News, the Associated Press and *El País*, covered the launch of the 2024 report.

Over the last three years, the report has been referenced by governments and organizations from the <u>Finnish Innovation</u> Fund (Sitra) and the <u>European External Action Service</u> to the <u>Organisation for Economic Cooperation and Development, the UN High Commissioner for Human Rights, the International Trade Union Confederation (ITUC), and the UN Development</u>

<u>Programme</u>. Ghana's speaker of parliament <u>referenced</u> analysis from the GSoD during a 2024 keynote address marking the University of Ghana's 75th anniversary.

The address traced the evolution of democratic governance in Ghana and reflected on the role of the country's parliament. The speaker's reference to the 2023 GSoD report is evidence of its value for political leadership and its ability to reach holders of the most influential political offices. Even more encouraging is the fact that the speaker referred to the report in front of an audience of current and former students of the University of Ghana to get them to reflect on declining faith in democracy among younger Africans and to call on young people to take notice.

The speaker delivered the message that Ghana's Parliament must prove that it is capable of delivering on its mandate—holding the executive to account, reducing corruption and addressing societal challenges—thus highlighting the report's role in institutional self-reflection and engagement with young people.

Reinforcing resilience against foreign information manipulation and interference


A workshop held in November 2024 produced a refined global methodology for identifying and analysing the factors that affect election-related foreign information manipulation and interference. The methodology empowers national stakeholders, particularly civil society organizations, to conduct country-level analyses and develop effective policy responses.

Stockholm Series of Public Lectures on Climate Change and Democracy


Policymakers, advisors, influencers, civil society organizations and scholars used the <u>Stockholm Series of Public Lectures on Climate Change and Democracy</u> to engage in a cross-discipline dialogue on the nexus between climate change and democracy.

The series, held between April and December 2024, inspired exchanges about the multiple linkages between climate change and democratic governance and created networks between the professional communities in both fields. The long-term objective of the lectures is to increase cooperation among these actors to contribute to more effective and inclusive climate action.

Through the Stockholm Series, International IDEA utilized its convening power to bring together its Member States and Stockholm-based institutions with a particular interest in climate change and democracy. Speakers in 2024 included Jennie King, Director of Climate Policy and Research at the Institute for Strategic Dialogue (23 April); Nicole Curato, Professor of Political Sociology at the Centre for Deliberative Democracy and Global Governance at the University of Canberra (11 June); Greta Ríos, Co-Executive Director of People Powered (12 November); and Luisa Neubauer, a climate justice activist and author (5 December). Over 1,000 people participated in person or virtually, and more than 260,000 people have viewed the lecture videos.

At a meeting in December, partner organizations confirmed their commitment to continuing the Stockholm Series in 2025. Together with them, International IDEA also proposed concrete steps to complement the Stockholm Series with in-person workshops on relevant topics.

Al Literacy for Electoral Actors: Global workshops for resilient elections

Theme: Digitalization and Democracy

To respond to the challenges that artificial intelligence (AI) presents for electoral management bodies (EMBs), International IDEA launched a project in 2024 on AI literacy for electoral actors.

The project seeks to improve Al literacy and resilience among EMBs and civil society worldwide. The objective is to harness Al's potential to improve electoral integrity while mitigating risks such as misinformation or marginalization by increasing knowledge on the part of EMBs and civil society. Two of five planned workshops have already taken place—in Kuala Lumpur, for electoral actors in the Asia-Pacific region, and in Tirana, for Eastern Europe and the Western Balkans.

Participants at the event in Kuala Lumpur expressed greater optimism than their counterparts at the event in Tirana, while the latter highlighted concerns over disinformation risks in particular. Participants at both events emphasized the importance of regulation and ethical standards to safeguard democracy.

Empowering voices: Youth Parliamentary Academy in Zambia



Funding: European Union

Theme: Political Participation and Representation

Twenty young adults from across Zambia gathered at the National Assembly in November 2024 for the Youth Parliamentary Academy, as part of the Inter Pares partnership with the National Assembly. Over four days, the participants deepened their understanding of representative democracy and improved their public-speaking and message-crafting skills.

What set the Academy apart from many other parliamentary initiatives for young people is that it empowered young adults who do not usually engage with parliament to take an active role in shaping their democracy. In addition to offering practical knowledge, international experiences, and context-specific exercises to help them express and defend their ideas, the Academy gave participants an opportunity to provide input into the Zambian Parliament's planned educational materials and youth strategy.


The National Assembly plans to create a youth participation strategy and a suite of educational materials, drawing on insights from the Youth Parliamentary Academy. Additionally, Inter Pares | Parliaments in Partnership, a global project to strengthen the capacity of parliaments, will make an Academy toolkit available that will serve as an open-source guide for other parliaments.

Strengthening Africa's premier network on democratic constitutionalism

International IDEA has been a long-standing partner of the African Network of Constitutional Lawyers (ANCL), which brings together communities of public intellectuals, judges, government officials, practitioners and members of civil society to enable peer exchanges and the sharing of knowledge on practical issues of democratic constitutional governance.

In December 2024 International IDEA supported the latest ANCL congress, which was convened in Dakar, Senegal, in collaboration with the Senegalese Association of Constitutional Lawyers.

The congress, which focused on improving democratic institutions in Africa, emphasized lessons learned from the experiences of non-Western countries and explored ways that traditional governance frameworks—prioritizing deliberation, consensus building and shared governance—can counterbalance the incumbency advantage and mitigate the effects of winner-takes-all politics.

The event gathered close to 150 participants, including former President Jorge Fonseca of Cabo Verde, a Senegalese government minister, prominent African intellectuals and civil society representatives.

Beyond the regional network, the ANCL's partnership with International IDEA extends into direct support at the country level. Following the congress in Dakar, for example, International IDEA engaged with participants from both Ghana and Senegal to support capacity-building and constitutional reform efforts.

International IDEA's role in the Pact for the Future and Global Digital Compact

International IDEA was a leading advocate for embedding democracy at the core of the UN's Pact for the Future, emphasizing the need to address democratic backsliding as a global challenge. This advocacy involved developing knowledge and analysis; reviewing successive drafts of the Pact, its Global Digital Compact and the Declaration on Future Generations; and making statements at the UN to highlight the critical role of democracy and human rights in global frameworks.

These efforts culminated in a significant milestone when International IDEA's Secretary-General underscored the importance of these principles during the Summit of the Future in September 2024 in statements at the UN General Assembly to all UN member states.

Bridging democracy and security: International IDEA's first NATO Summit event

On the margins of the NATO Summit in July 2024, held in Washington DC, International IDEA convened an event titled 'Strengthening Security through Democratic Resilience'. The event brought together experts from two communities that rarely interact—democracy assistance and security and defence—for a dialogue on the nexus between democracy and global security.

By bridging the gap between two traditionally separate spheres, the event identified vital insights into how democratic principles underpin effective security strategies. It also reaffirmed the shared mission to build a secure and democratic future on both sides of the Atlantic and across the world.

Global democracy campaign: #ThankYouDemocracy

International IDEA, together with more than 140 partners in the global democracy community, has been convening the <u>Global Democracy Coalition</u> since 2021. The 2024 #ThankYouDemocracy campaign, initiated by the Coalition, enabled democracy defenders from the Coalition and beyond to share their stories of why and how democracy matters. The campaign brought together partners from all regions, empowering them to showcase democracy's tangible benefits through a series of positive-outcome stories and podcasts, social media engagement and targeted advocacy efforts.

As a host of the Coalition, International IDEA played a pivotal role in bringing together diverse voices and fostering collaboration across regions. Through this effort, the campaign not only strengthened global advocacy for democracy but also created spaces for meaningful engagement, equipping partners with the tools and platforms needed to highlight democracy's role in addressing today's most pressing challenges.

The campaign engaged democracy advocates worldwide, grassroots champions and global leaders, such as Carlos Alvarado, Tsakhia Elbegdorj, Leonel Fernández, Eduardo Frei, Stefan Löfven, Moussa Mara, Hanna Suchocka, Jigme Yoser Thinley and José Luis R. Zapatero, among others.

Reducing prison overcrowding in Nigeria and improving defendants' rights

Funding: European Union

Theme: Constitution-Building and Rule of Law

Seventy per cent of the people in Nigeria's prisons are still awaiting trial, some for seven years or more. In Lagos, magistrates are reluctant to grant bail to defendants out of concern that they may abscond once released.

To address this concern, International IDEA, through its Rule of Law and Anti-Corruption Programme in Nigeria, collaborated with the Lagos state judiciary to build a Bail Information Management System (BIMS). BIMS captures biometric and other data from defendants and their sureties, which can be used to track and rearrest absconding defendants. Thanks to BIMS, magistrates are more confident when granting bail, knowing that the chances that a defendant will evade trial are slim.

BIMS is now operative in 14 magisterial districts and has spared 7,223 defendants from pre-trial detention.

Rule of Law and Anti-Corruption Programme supports free legal services at Nigerian Bar Association conference

Funding: European Union

Theme: Constitution-Building and Rule of Law

The Duty Solicitor Network of Nigeria, with support from International IDEA's Rule of Law and Anti-Corruption Programme, facilitated a series of legal aid clinics during the Nigerian Bar Association's Annual General Conference in 2024.

With the participation of 102 volunteers (74 women, 28 men) from two government agencies and nine civil society organizations, the clinics offered a platform that enabled 214 beneficiaries (149 women, 65 men) to receive legal advice and representation in various civil cases. The initiative sought to enhance access to justice by offering free legal aid to marginalized groups.

Gambian National Assembly approves first code of conduct for members

Funding: European Union

Themes: Constitution-Building, Political Participation and Representation

As part of the CODE Project, the Gambian National Assembly adopted its first-ever code of conduct for its members in 2024, with support from International IDEA.

This marks a milestone for The Gambia, as it is the National Assembly's first codified and gazetted code of conduct since independence. The document will play a major role in ensuring that members of parliament adhere to the highest ethical standards. This activity was implemented with the support of the Irish Parliament, which has continued its partnership with the Gambian National Assembly that began as part of the Inter Pares | Parliaments in Partnership, a global project to strengthen the capacity of parliaments.

The Ethics and Privileges Committee has committed to ensuring the full implementation of the code of conduct.

A former youth parliamentarian, Faye has been involved in civic education, women's political participation and youth empowerment since the age of 13. Previously, in 2014, the Moremi Initiative recognized her as one of Africa's 25 most outstanding emerging young women leaders.

Promoting political-party conflict resolution to empower women lawmakers in Sierra Leone

Funding: European Union

Theme: Political Participation and Representation

International IDEA has been working on a two-year project to strengthen Sierra Leone's democracy, including promoting reforms within political parties and encouraging women, youth and people with special needs to take part in electoral processes.

The project has included promoting political-party conflict resolution as well as empowering women lawmakers and pushing plans to monitor over 200 radio stations and 12 TV stations for inflammatory speech.

Sierra Leone has held five elections since its 11-year civil war ended in 2002. The fact that the latest election was widely seen as the least violent is a testament to the work of International IDEA and its partners in fostering governance and civil discourse among parties, election officials and voters.

Supporting transitional authorities in Gabon

Funding: Earmarked core funding from the Netherlands

Theme: Constitution-Building

The Committee for the Transition and Restoration of Institutions took power during the coup d'état that took place in Gabon in 2023. In 2024 the transitional authorities in Gabon consulted International IDEA for advice on how to shape the country's political transitional process.

International IDEA analysed the ongoing political transition in the country and deployed a mission to Gabon to help support the constitutional reform process.

The transitional authorities implemented some of the suggestions, such as unamendable provisions and provisions on duties to protect the constitution.

Moreover, International IDEA provided an induction

session for 150 members of the Transitional National Assembly and of the Transitional Senate on the constitution-building process. The Institute also provided training on electoral risk management for 15 senior staff members at the Ministry of the Interior and Security's General Directorate of Elections and for 15 representatives of civil society organizations. The training resulted in a risk analysis that outlined mitigation measures in preparation for the constitutional referendum that took place on 16 November 2024.

Asia and the Pacific

Indigenous dialogue strengthens advocacy in Asia

International IDEA organized two round tables on Indigenous inclusion that provided a venue for insightful dialogue about inclusion and representation. Despite being home to the largest number of Indigenous Peoples in the world, Asia has some of the most exclusionary practices towards them. For example, wide gaps in legislative and institutional frameworks leave Indigenous communities vulnerable to rights violations.

Despite the challenges posed by shrinking civic space, Indigenous Peoples in Asia have developed innovative strategies to assert and protect their rights. In Nepal, for example, the Tharu community has revitalized their traditional Barghar system, where the Barghar, akin to a ward chair, plays a central role in local governance. This system allows the Tharu to maintain their cultural and legal autonomy within the broader state framework.

Building global parliamentary networks in Myanmar

Funding: Finland, Luxembourg and Norway

Theme: Political Participation and Representation

Following the coup that took place in Myanmar in 2021, the Committee Representing Pyidaungsu Hluttaw (CRPH)—the country's legitimate interim parliament—used peer-to-peer exchanges and outreach with parliaments to raise awareness of Myanmar's crisis in multilateral and regional forums.

Supported by International IDEA's Building Federal Democracy in Myanmar programme, CRPH members engaged extensively with the Inter-Parliamentary Union (IPU). This relationship began in 2022, when the CRPH chairperson attended the UN General Assembly–IPU meeting in New York, opening doors for dialogue on Myanmar and parliamentary best practices.

In 2023 and 2024 the programme facilitated the participation of CRPH delegations in IPU assemblies in Angola, Bahrain and Switzerland that addressed themes such as parliamentary diplomacy and harnessing innovation for peace. Delegates engaged in bilateral meetings with members of parliament from Canada, Germany and Ghana, among other countries, and spoke on Myanmar's situation in plenary sessions.

These efforts strengthened international recognition of Myanmar's interim parliament, reinforced bilateral relationships and secured the IPU Governing Council's decision to maintain the CRPH as its primary interlocutor on Myanmar.



Bhutanese delegation explores Australian parliamentary innovations

Committed to strengthening effective democratic institutions and honing best practices, International IDEA was honoured to host a seven-member parliamentary delegation from Bhutan, led by Hon. Sangay Khandu, Deputy Speaker of the National Assembly, in Australia in October. The purpose of the trip was for the delegation to learn from Australian legislatures' public awareness programmes, youth engagement strategies and visitor management practices.

The delegation visited the Victorian State Parliament, the Australian Capital Territory Legislative Assembly and the Australian Parliament House, gaining a perspective of both state and federal parliamentary

practices. These visits highlighted Australia's use of interactive exhibits and educational programmes to engage students and foster public understanding of parliamentary functions—a concept the Bhutanese delegation expressed keen interest in adopting.

The visit underscored Bhutan's commitment to fostering a transparent, youth-focused and accessible parliament. Follow-up initiatives, including new parliamentary education and visitor programmes, will be rolled out in 2025 through the project Nyamdrel II: Support to CSOs and Parliament of Bhutan.

Charting a path to recovery: Strengthening Ukraine's electoral readiness

Funding: Liechtenstein and earmarked core funding from Sweden

Theme: Electoral Processes

Millions of people have been displaced since Russia's full-scale invasion of Ukraine in February 2022. Although holding elections is prohibited while the country is under martial law, voters could be called to the polls soon after the war ends. In light of this eventuality, International IDEA is supporting preparations for potential post-war elections. These preparations include enabling out-of-country voting, helping the authorities identify and mitigate risks to election integrity, and developing communication strategies for post-war elections. To strengthen its support, International IDEA opened an office in Kyiv.

The Institute arranged visits in 2024 for election commission officials and diplomats to EU member states—including Estonia, Italy, Romania and Spain—and Moldova to explore how to organize out-of-country voting. During these trips, discussions

were held with host countries about the conditions necessary for hosting Ukrainian elections on their territory.

The Institute trained election officials on protecting elections, covering risk management—including security threats, foreign interference and election malfunctioning—building resilience and strengthening the capacity to manage crises.

How Moldova is tackling online disinformation in elections

Funding: Sweden and Core

Themes: Digitalization and Democracy, Money in Politics

In 2024 Moldova held a simultaneous presidential election and referendum on EU integration. Given the geopolitical importance of these votes, the country faced growing threats to its electoral integrity from digital disinformation and unregulated online campaign financing. In response, International IDEA partnered with Moldova's Central Electoral Commission (CEC) to track online campaign expenditures and identify illicit campaigns. This assistance laid the groundwork for regulatory updates and improved the CEC's capacity to respond to threats.

Previously, the CEC had limited tools to detect unauthorized expenditures and coordinated disinformation. With International IDEA's training and new monitoring approaches, it gained regular

insights into the campaign expenditures and activities of electoral and referendum actors. Weekly reports compiled by International IDEA identified illicit advertising, fake accounts and disinformation networks. Based on online monitoring tools and platform libraries, International IDEA's analysis raised the CEC's awareness of digital threats and improved collaboration with stakeholders in order to respond to those threats.

Strengthening Moldova's digital resilience is key to safeguarding the country's democracy. With this experience and support from International IDEA, the CEC is planning to enhance its monitoring for the country's parliamentary elections in 2025.

Driving ethical campaign standards for 2024 European elections

Funding:

International IDEA's Regional Europe Programme team helped ensure transparent and ethical campaigning for the 2024 European Parliament elections. Their engagement with the European Commission in 2023 led to a recommendation in the EU's Defence of Democracy Package on public pledges for ethical online campaigning ahead of the 2024 elections. Building on this recommendation, the team presented their experience with the 2021 Dutch Code of Conduct at a meeting with Commission Vice-President Vera Jourová and the 10 European political party families in February 2024. As a consequence, International IDEA was asked to facilitate the development of a code of conduct for the European Parliament elections.

Led by International IDEA and involving all 10 European political party families, the drafting and negotiation process resulted in a document in which all 10 European political parties made 14 commitments for transparent and fair campaigning, especially in the online sphere. The signing of the

code of conduct, at a ceremony hosted by Vice-President Jourová on 9 April 2024, marked a milestone in terms of enhancing integrity and accountability in European Parliament elections. Various media reported on the code.

To increase public awareness, the team presented the code of conduct to all 27 European electoral commissions, the European Commission, representatives of EU member states, the Danish Parliament, the Organization for Security and Cooperation in Europe's Office for Democratic Institutions and Human Rights and the Victoria Electoral Commission, ensuring widespread recognition of these ethical standards at both the European and international levels.

Global leaders urge EU to prioritize democracy action

In the run-up to the European Parliament elections in June 2024, International IDEA's Regional Europe Programme spearheaded a public statement titled 'Call to Defend Democracy: 10 Priorities for the Next European Commission'. The statement garnered the endorsement of over 350 prominent organizations and personalities, underscoring the urgent need to uphold democratic values within and beyond European borders. The statement showed the imperative for the forthcoming EU leadership to prioritize democratic values amid rising authoritarianism. It highlighted 10 key priorities,

urging the EU to fortify its internal democratic

structures, enhance the rule of law and ensure that new digital technologies safeguard human rights. The EU was also called upon to place democracy at the centre of its external agenda, by integrating democracy into trade and investment, safeguarding electoral integrity, emphasizing democracy in EU-enlargement efforts, and increasing resources for democracy and civic space programs globally.

Prominent figures such as Nobel Peace Prize Laureates José Ramos-Horta of Timor-Leste, Sviatlana Tsikhanouskaya of Belarus and Muhammad Yunus of Bangladesh, two dozen former heads of state and leading EU officials lent their influential voices. As European citizens prepared to vote, the statement aimed to mobilize policymakers, stressing that democracy remains the most effective system for addressing societal challenges and protecting the rights of all citizens. The statement was featured by media globally.

Latin America and the Caribbean has enjoyed success with respect to representation, participation and inclusion. For example, the region has seen improvements in women's political representation and the successful organization of elections.

Despite these gains, some countries continue to suffer from high levels of inequality, while also experiencing democratic setbacks and confronting

new challenges that are straining governance, stability and the possibility of equitable growth and well-being for their citizens.

International IDEA partnered with the Spanish Agency for International Development Cooperation (AECID) and its training centre in Antigua, Guatemala, to organize a conference to analyse the causes of democratic backsliding and outline possible strategies to strengthen democratic resilience in the region. Participants included representatives from across Latin America, Spain and the USA, including academics, legislators, non-governmental organizations, youth and women's organizations, journalists and other media professionals as well as intergovernmental and international cooperation institutions.

The AECID worked on the methodology for the dialogue, together with international IDEA. The dialogue provided a space for exploring the causes of democratic deterioration in Latin America and the Caribbean and addressing how these setbacks could be reversed.

The conference enabled participants to identify common challenges and strategies to support democratic resilience. The final plenary and group discussions unanimously reaffirmed that collective efforts can, and must, prevent backsliding and protect democratic gains in the region.

A major step forward in women's political participation in Mexico

Claudia Sheinbaum won the June 2024 election with more than 50 per cent of the vote, becoming Mexico's first female president. In addition, since the implementation of the 'Parity in Everything' law, more than half of Congress is made up of women. This is a milestone in women's participation, political representation and access to power.

International IDEA accompanied this electoral process through several technical assistance missions to the National Electoral Institute of Mexico, mainly focused on monitoring the gender agenda and the digitalization processes applied to the general elections.

This included dialogues with electoral authorities, civil society actors, representatives of political parties and candidates. Experts also attended one of the presidential debates, which focused on economic development, poverty, inequality and climate change.

International IDEA's work in Mexico highlights the

importance of collaboration between different organizations and institutions to address complex issues such as political violence, polarization and disinformation, and points to the need for future processes that prioritize civic media education and literacy.

Peru Deliberates: A transformative experience in citizen dialogue

Funding: US Agency for International Development (USAID)

Theme: Political Participation and Representation

Peru Deliberates (Delibera Perú), a groundbreaking event designed to improve citizen participation and political representation, inspired by successful international models, took place on 5 October 2024. Held in a context of distrust in democracy and low political engagement, it aimed to renew optimism by bringing together 177 participants from all over Peru.

Participants debated issues such voluntary voting, deliberation among local residents, regional movements and reserved congressional seats for Indigenous and Afro-Peruvian peoples.

Notably, 90 per cent of the participants said that they felt more informed, and the portion of participants who believed that their political opinions were unimportant dropped from 15 per cent to just 5 per cent, based on survey responses before and after the deliberation process. <u>Peru Deliberates</u> proved that inclusive dialogue can rebuild trust in democracy and bridge divides in a polarized society.












Number of publication downloads in 2024, top 10 countries











Expenditure by theme (activities only)




