Global postal voting


Special Voting Arrangements data

As of 2025, 32 countries offer mail-in (postal) voting in different shapes and forms. Countries that offer postal voting commonly do this as an alternative to, not as a replacement of, voting in polling stations for national elections.

Yet how countries implement or regulate postal voting varies greatly. These variations include deadlines, eligibility (who, under what conditions), formats (type of envelope), tracking systems (if any), security features (such witness requirements), collection points, counting processes (at polling stations, dedicated regional/ national counting centers), deadlines, mail-out 'direction' (is the postal ballot mailed out or picked up; is it mailed back or can it be submitted in person).

Postal voting and the United States

Special Voting Arrangements data

Just as there is no uniform postal voting system across countries, there is no uniform postal voting system across the states of the United States. Features of in-country postal voting where the United States differs from other countries include:

- Ballot tracking from voter to counting center, as practised in parts of the United States, is a transparency feature not yet available in most other countries.
- Decentralised election administration. Most countries have the same postal voting systems and regulations for the entire nation, while in the United States, the system differs from state to state, or even county to county.
- The option to correct an invalidly submitted ballot ('curing the ballot') is uncommon globally.
