She joined CHESNO in 2015 as a leader of a nationwide campaign on strengthening transparency and accountability of local authorities and political parties. Previously, Vita worked at Kyiv School of Economics as a project manager. In 2019 Vita, as a consultant of the World Bank, worked on a

Oriana Ivković Novokmet is the Executive Director of Gong, a galvanizer for democracy: disrupting corruption, alerting on political threats and building active citizenship. She has a degree in journalism at the Faculty of Political Science of Zagreb University and has worked as editor and journalist in several traditional and online news media. In 2019 Oriana received two awards from the Croatian Journalists' Association for investigative (Jasna Babic Award ) and online journalism (Marija Juric Zagorka Award). Gong started out in 1997 focussing on election observation. Currently the organization is

leading monitoring and advocacy initiatives on anti-corruption, freedom of information and open data focusing on transparency, accountability, citizen engagement, open data and media literacy.

Gong is experienced in\_innovating digital projects related to <u>election finances searchable databases</u> and relevant public policies, sharing knowledge and building tools such as the <u>Mosaic of Connections</u> - the database on politically exposed persons and their relationships, based on data from public registries. In partnership with civic hackers from the Code for Croatia group, Gong enables the <u>citizens to easily access public information</u> and organises annual Open Data Weekends.

He has worked at the parliament of Georgia, National Democratic Institute (NDI), and has been writing analytical essays for different magazines.

Sandra Pernar joined the Open Government Partnership in April 2018. She provides guidance and assistance to governments in Europe, primarily in Southern and Eastern Europe, facilities exchange and learning between governments, as well as support to civil society organizations in these countries to push for open government reforms.
