# **REQUEST FOR PROPOSALS**

### Section 1 General Information

- 1.1 The International Institute for Democracy and Electoral Assistance (International IDEA) is an intergovernmental organization established in 1995, with member states across all continents, which aims to support sustainable democracy world-wide and assist in the development of institutions and the culture of democracy. At the interface between research, fieldwork and the donor community, IDEA provides a forum for dialogue, builds networks of experts, develops training materials and provides strategic advice at international, regional and national level, cooperating with a range of organizations. The Institute, which is funded, inter alia, by the European Union (EU), implements projects in Nigeria, at the federal level and currently in 7 states Abia, Adamawa, Anambra, Edo, Kano, Lagos and Plateau. Additional states may be added in future.
- 1.2 International IDEA now invites proposals from qualified consultants (firms, organizations, individuals) for the construction of a New Building for the Mirabel Sexual Assault Referral Centre (SARC) in Lagos, Nigeria.
- 1.3 The services include construction works, as well as other related tasks below but is not limited to:
  - 1.3.1 Building construction (new structures)
  - 1.3.2 Electrical and plumbing installations.
  - 1.3.3 Structural repairs and finishing works.

A detailed description of the assignment is provided in the Terms of Reference attached.

1.4 Tentative timeframe: It is anticipated that the services will commence by the **first quarter** of 2026 and they will have to be completed by the **second quarter of 2026.**

**2.1 Language:** All submissions shall be written in English and must be submitted in electronic format by e-mail. If you are interested in this tender, please respond by submitting the following documents.

### **Financial Proposal**

- 2.3 Financial Proposal: Kindly note the financial proposal should be all inclusive of all costs, VAT where applicable or any other indirect taxes and incidental expenses likely to incur which will be applicable to this assignment. International IDEA is not tax exempt and does not have a VAT number.
- 2.4 The Supplier shall be expected to submit a **Financial Proposal in line with the template** specified as Annex 6- Unpriced Bill of Quantities (BoQ) in Microsoft Excel format.

# Section 3 Submission of Supporting statement.

- 3.1 The documents can be sent as a PDF-file or a Word-file. Please specify and submit each mandatory technical requirement listed under Section 2.2 (a-c) as a separate and duly marked file. All large files should be submitted in separate emails, duly labelled (email 1 of 2 etc., as relevant).
- 3.2 Proposals must be submitted in separate files and marked accordingly. The full details on how to submit proposals is under Tender Notice at the beginning of this document. Please note that the technical proposal should provide the information as outlined under section 4.1 of this tender notice.
- 3.3 Proposals must remain valid for at least 60 days following the deadline for their submission stated under the Tender Notice. During this period, the consultants are expected to keep available the professional staff proposed for the assignment.

## Section 4 Evaluation of Proposals

**4.1 Technical Evaluation:** The **technical proposals** from individuals and organisations will be evaluated and scored against the following technical criteria with respective corresponding weights:

The maximum technical score (T) is 100 points. Only proposals that meet a minimum of 60 points in the technical evaluation will be considered for financial evaluation.

### **Financial Evaluation:**

- 4.2. The financial proposals will be verified and, if necessary, adjustments will be made to the prices to ensure consistency with the technical proposals in terms of work input and to eliminate arithmetical errors.
- 4.3 The currency used for evaluation is Naira.
- 4.4 The financial scores (F) will be computed as follows:

The lowest evaluation price proposal (E<sub>m</sub>) will be given a financial score (F<sub>m</sub>) of 100 points.

The financial scores of the other proposals will be computed applying the formula:

 $F = 100 \text{ x } E_m/E$ , where:  $E_m$  is the lowest evaluation price, and

E is the evaluation price of the proposal under consideration.

### **Consolidated Technical and Financial Score:**

4.5 The final consolidated scores (S) will be computed by applying the formula:

 $S = t \times T + f \times F$ , where: t is the weight given to the technical score f is the weight given to the financial score

4.6 The weights given to the technical and financial scores are:

t = 60%

f = 40%

- 4.7 The service provider ranked highest will be invited to negotiate the contract and if negotiations are successful the selected service provider will be awarded the contract. Should the negotiations fail; the second ranked service provider will be invited to negotiations.
- 4.8 International IDEA reserves the right during the negotiation stage to vary at the time of award of contract, the quantity of services and/or goods, or scope of work by up to a maximum of twenty-five per cent (25%) of the original TOR. This negotiation will not permit any changes to unit fee rates or other terms and conditions outlined in the tender proposal.
- 4.9 International IDEA reserves the right to directly award a follow up contract to the contractor selected for the tender to carry out potential future work related to this initial assignment. This will depend on satisfactory delivery of the tender assignment.
